	1. Save to the extent that the declaration set out in the Divisional Court's
	order dated 24 February 2019 is replaced by the declaration in paragraph
	2 below, the appeal is dismissed.
	2. It is declared that the earned income calculation method in Chapter 2 of
	Part 6 of the Universal Credit Regulations 2013 is irrational and unlawful
	as employees paid monthly salary, whose universal credit claim began on

or around their normal pay date, are treated as having variable earned income in different assessment periods when pay dates for two (consecutive) months fall in the same assessment period in the way described in the judgment.

- 3. The Appellant shall pay the Respondents' costs to be assessed on the standard basis if not agreed.
- 4. Pursuant to CPR 42.8, the Appellant shall make an interim payment in respect of the Respondents' costs in the amounts of £25,000 (First Respondent) and £25,000 (Second-Fourth Respondents) within 14 days of the date of this order.
- 5. There shall be detailed assessment of the Respondents' publicly-funded costs.
